- V. Approval of minutes from last meeting
  - **Resolved:** Minutes from ANUFC Committee Meeting 04/06/2020 are accurate to the proceedings of said meeting, and subsequently approved

### VI. Open Issues

- a) Return to play plan
  - o Now accepted by both ANU Sport and Capital Football
- b) Training Plan
  - Brett: Coaches unsure about how to utilize Tom's offer for training sessions. Tom offered to write up plans formally. We could request Tom to do this and send it to coaches.
  - ACTION: Harrison to contact Tom for training plans consistent with the return to play plan
  - ACTION: Harrison to send the coaches the plan and the rules they need to follow

## c) Rego fees

- Jonathan asked whether the club should aim to turn a profit or aim to break even
- Brett said better to turn a profit and look to financing a resurfacing of willows
- Jonathan presented the committee with differently modeled budgets
- o Due to students possibly not returning there may be inaccuracies



- o Assumption of 16 players per team
- o Mix of teams off and on campus seems to be preferred by the club coaches
- Greg brought up discrepancy between ANUFC constitution and ANU Sport requirements
- Brett pointed out our fees are structured in such as way that it circumvents the discrepancy
- Greg pointed out ANUFC does not have to strictly adhere to some aspects of constitution that do not align to registrar generals specifications
- Jonathan prefers scenario two (mixed on and off campus training/games)
- o Jonathan suggested two weeks before players have to register
- o The committee discussed the best way to confirm student IDs
- Brett pointed out that there is a minimum difference required between student and non student fees
- Jonathan pointed out committee will have to refund those who have registered already
- o Brett moved we enforce these fees
  - Greg seconded
- o Brett moves that we make fees due 21st
  - Ryan seconded
- o ACTION: Jonathan to email club and make facebook post re fees.
- o Brett points out we should make clear to members that they do not need to pay CF fees to keep training only ANU Sport membership.
- o Brett asked if the club would be interested in Saturday "scratch matches"
- d) Team nominations



- o Brett pointed out till CF requests this its quite relaxed
- o Brett pointed out we need to poll coaches for training preferences
- Jonathan replied that this is usually done through coaches

#### e) Fields

- o ACTION: Jonathan to add O'connor 2 to Return to Play Plan
- ACTION: Greg to send plan to CF and get approval
- ACTION: Brett to send plan to ANU Sport to get approval

- o Fairly normal presentation night expected with restrictions lifting
- o Brett: Committee should consider streaming AGM
- ACTION: Ryan to look into games/ways to engage people during AGM
- Greg: Committee should consider splitting the AGM and Presentation night
- o Brett: AGM elections should be at the start of AGM/Presentation night

#### VII. New Business

o ANU Sport board nomination meeting



- o ANU Sport asserts they want to maintain good relations with ANUFC
- o Funding for South Oval Development was secured 6 years ago
- There is a plan for \$2 million redevelopment of Willows Oval, though this will not looked at until after South Oval development
- o 3 positions up for election, you must be an ANU Sport member
- Elections are staggered
- o 16<sup>th</sup> deadline for nominations
- a) Hand Sanitizer
  - o The committee gave Brett permission to buy hand sanitizer for training
  - o ACTION: Brett to purchase hand sanitizer, around 8 bottles
