ANUFC Membership Terms and Conditions

1. Membership Arrangement

- 1.1. It is the individual's responsibility to register for the correct club membership category and inform the club and ANU Sport of any change that may affect their eligibility for membership status.
- 1.2. It is the responsibility of ANU Students to inform ANU Sport if they graduate from or cease enrolment at the ANU during the period of their club membership. Students in this situation will be required to pay an amount of the ANU Sport Club Affiliation Fee to maintain their ANU Sport membership status and insurance coverage.
- 1.3. Persons under 16 are ineligible for club membership unless a written application for special consideration is lodged and approved by the ANU Sport Board.
- 1.4. Club memberships are not transferable.

2. ANU Sport Membership

- 2.1. ANU Sport membership entitles the member to:
 - 2.1.1. vote at ANU Sport's Annual General Meeting;
 - 2.1.2. stand for positions on the Board of ANU Sport;
 - 2.1.3. purchase ANU Sport Fitness Centre memberships at the club member rate.
 - 2.1.4. receive discounted rates for facility hire
- 2.2. All club members who pay an ANU Sport Club Affiliation Fee are covered under ANU Sport Group Personal Accident and Sickness, and Public Liability insurance policies for club activities during the period of their club membership.
- 2.3. ANU Sport and club memberships will start and end at the same time.
- 2.4. ANU Sport memberships are not transferable.

3. Data

- 3.1. Club members personal information will be stored in line with the ANU Sport Privacy Policy.
- 3.2. Club members' personal information will be stored by clubs and ANU Sport.
- 3.3. ANU Sport has the right to use stored information for reporting club membership data and for tracking membership eligibility and renewals.

4. Behaviour

- 4.1. ANU Sport staff may, by their own discretion, ask any club member acting inappropriately to leave ANU Sport facilities. Club members are expected to abide by directions given by ANU Sport staff and/or relevant club officials or risk forfeiting their ANU Sport and club memberships.
 - 4.1.1. All affiliated members agree to behave in accordance with the expectations of ANU Sport
 - 4.1.2. Ensure your decisions and actions contribute to a harassment-free environment.
 - 4.1.3. Ensure that any physical contact with another person is appropriate to the situation and necessary for the person's skill development.
 - 4.1.4. Do not bully or condone any kind of bullying or violence.
 - 4.1.5. Never act in a discriminatory way to another individual.
 - 4.1.6. Do not use bad language or make derogatory remarks.
 - 4.1.7. Do not engage in activities that bring ANU, ANU Sport and/or the Club into disrepute;
 - 4.1.8. Do not engage in activities that are illegal and deemed detrimental to the club and/or ANU Sport;
 - 4.1.9. Do not engage in activities that compromise the safety of other members, or members of the public;
 - 4.1.10. Do not intentionally misused ANU Sport assets; and/or
 - 4.1.11. Do not misappropriate funds;

4.2. Indemnity

- 4.3. Each club member indemnifies and releases ANU Sport from any claim arising as a result of the club member's use of ANU Sport facilities or participation in ANU Sport and affiliated club programs.
- 4.4. Each club member uses the ANU Sport's facilities and participates in ANU Sport programs at their own risk. Please be aware that any form of physical activity may have inherent risks associated with it. If you have any concerns regarding your health or physical fitness, please see your doctor prior to participating in any of our programs, or before using any of our facilities.

5. Refund

- 5.1. If club membership is cancelled (other than for a breach of these conditions) then the member may be reimbursed for the balance of the ANU Sport Club Affiliation Fee.

6. Disciplinary Action Against Club Members

- 6.1. ANU Sport may approve, refuse or cancel the club membership of any person at its discretion.
- 6.2. ANU Sport may suspend the membership of a Club member if it considers that the member has breach these terms and conditions.
- 6.3. ANU Sport may cancel the membership of a Club member after suspension if:
 - 6.3.1. The member cannot adequately defend themselves against the reason for suspension; and/or
 - 6.3.2. The member has not taken the corrective action specified by ANU Sport.
- 6.4. ANU Sport must provide the member notice, in writing, of the reasons for the cancellation.
- 6.5. The member will have seven (7) working days to respond before cancellation takes effect. If the member fails to respond or the response is considered by ANU Sport to be inadequate, ANU Sport will cancel the membership of the member.
- 6.6. The member may appeal in writing to the ANU Sport Board against the suspension or cancellation of their affiliation.
